STREET DIRECTORY.

- Brick*, north from Deming to North first west of Coal.
- Broad*, west from Tallmadge Avenue to 4th street first south of Portage.
- Canal*, north from Portage to North first east of P. & O. Canal.
- Center*, west from High, to Canal first north of Grant
- Chestnut*, west from Front to Third near south Corp. Line.
- Coal*, north from Deming to North first west of High.
- Deming*, east from Canal to east Corporation Line first south of Portage.
- Falls*, west from Front to 4th first south of Broad.
- Fourth*, south from Wadsworth to near Falls first west of 3d.
- Front*, south from corner Stow Avenue and North to south Corporation Line first west of Cuyahoga River.
- Grand*, west from High to P. & O. Canal first north of Portage.
- High*, north from Deming to North first west of east Corporation Line.
- Main*, north from corner Taylor and Middlebury Av. to Grand, side of P. & O. Canal.
- Middlebury Avenue*, south from corner Main and Taylor.
- Newberry*, north from Taylor to Tallmadge Av. first east of Main
- North*, north west from corner of Stow Avenue and Rock to 3d
- North*, east from Canal first north of Oak.
- Northampton Avenue*, north west from corner of Fourth and Portage.
- Oak*, west from High to Canal first north of Center.
- Pool*, west from Front to Second first south of Falls
- Portage*, west from High to Fourth first north of Broad.

Prospect, east from Main to William first south of Sill.

Reed, east from Cuyahoga River, to Tallmadge Avenue first

Rock, south east from corner of north and Stow Avenue to Cuyahoga River.

Second, south from corner Stow Avenue and North to south Corporation Line, first west of Front

Sill, east from P. & O. Canal to Tallmadge Avenue.

Stone, north from Deming to Canal first west of Brick.

Stow, west from Front to Fourth first north of Portage.

Stow Avenue, north east from north end of Front first north west of Cuyahoga River.

Tallmadge Avenue, south east from corner Broad and Newberry.

Taylor, east from C. Z. & C. R. R. to William first south of Prospect.

Third, south from North to Falls first west of Second.

Wadsworth, north west from Front to Fourth north east of Wetmore.

Wetmore, north west from Cuyahoga River to Fourth first north east of Stow.

William, north from Taylor to Tallmadge Avenue first east of Newberry.
